Pursuant to the Pre-IPO Share Option Schemes (which comprises the Mid-Senior Level Management Pre-IPO Share Option Scheme and the Non-managerial Employee Pre-IPO Share Option Scheme) both adopted on 12 March 2019, as at the date of this monthly return, there were a total of 19,794,500 outstanding share options, including (1) share options to subscribe for 3,343,300 new ordinary shares of the Company which were vested in June 2020; and (2) share options to subscribe for 6,089,100 new ordinary shares of the Company which were vested in December 2020. The remaining share options remained unvested as at the date of this monthly return. 6,800 share options were lapsed in December 2020.
