**(1) Pursuant to the Pre-IPO Share Option Schemes (which comprises the Mid-Senior Level Management Pre-IPO Share Option Scheme and the Non-managerial Employee Pre-IPO Share Option Scheme) both adopted on 12 March 2019, as at the date of this monthly return, there were 22,603,500 outstanding share options, among which options to subscribe for 6,138,800 new ordinary shares of the Company vested in June 2020 while the remaining share options remained unvested as at the date of this monthly return, and 46,800 share options were lapsed in September 2020.**
