VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

This announcement is issued by Renrui Human Resources Technology Holdings Limited (the “**Company**”, and together with its subsidiaries, collectively referred to as the “**Group**”) as a voluntary announcement to provide its shareholders and potential investors with the latest business development of the Group.

As comprehensive flexible staffing services is the major business segment of the Group, the Group has been focusing on the development of this business segment and the continuous recruitment of comprehensive flexible staffing employees to provide services to clients. The board of directors (the “**Board**”) of the Company is pleased to announce that the number of the Group’s comprehensive flexible staffing employees has increased from 46,985 *(note 1)* as at 31 July 2021 to 49,321 as at 31 August 2021, representing an increase of 2,336 or a positive growth rate of approximately 5.0%. Such number of comprehensive flexible staffing employees as at 31 August 2021 represents an increase of 16,031 or a positive growth rate of approximately 48.2% as compared to 33,290 *(note 2)* comprehensive flexible staffing employees as at 31 August 2020.

Notes:

- (1) They comprise 41,904 flexible staffing employees and 5,081 business process outsourcing employees since the Group has combined two previously disclosed business segments, namely, flexible staffing and business process outsourcing, to comprehensive flexible staffing for the six months ended 30 June 2021.
- (2) They comprise 30,327 flexible staffing employees and 2,963 business process outsourcing employees.

The Group will continue to strengthen its position in the comprehensive flexible staffing industry in the PRC by providing quality services to its clients.
