(1) Pursuant to the Pre-IPO Share Option Schemes (which comprises the Mid-Senior Level Management Pre-IPO Share Option Scheme and the Non-managerial Employee Pre-IPO Share Option Scheme) both adopted on 12 March 2019, as at the date of last monthly return, there were 22,747,100 share options, out of which 40,000 share options were lapsed in April 2020 and 22,707,100 share options (to subscribe for 22,707,100 new ordinary shares of the Company) remain unvested as at the date of this monthly return.
