(1) Pursuant to the Pre-IPO Share Option Schemes (which comprises the Mid-Senior Level Management Pre-IPO Share Option Scheme and the Non-managerial Employee Pre-IPO Share Option Scheme) both adopted on 12 March 2019, as at the date of this monthly return, there were a total of 19,665,900 outstanding share options, among which (a) share options to subscribe for 3,343,300 new ordinary shares of the Company were vested in June 2020; (b) share options to subscribe for 6,010,900 new ordinary shares of the Company were vested in December 2020; and (c) share options to subscribe for 6,056,200 new ordinary shares of the Company were vested in June 2021. The remaining share options remained unvested as at the date of this monthly return. 10,000 unvested share options were lapsed in June 2021.

(2) Pursuant to the Post-IPO Share Option Scheme adopted on 26 November 2019, as at the date of this monthly return, there were a total of 2,950,000 outstanding share options, among which share options to subscribe for 80,000 new ordinary shares of the Company were vested in May 2021. The remaining share options remained unvested as at the date of this monthly return.
