(1) Pursuant to the Pre-IPO Share Option Schemes (which comprises the Mid-Senior Level Management Pre-IPO Share Option Scheme and the Non-managerial Employee Pre-IPO Share Option Scheme) both adopted on 12 March 2019, as at the date of this monthly return, there were a total of 19,623,400 outstanding share options, among which (a) share options to subscribe for 3,343,300 new ordinary shares of the Company were vested in June 2020; (b) share options to subscribe for 6,010,900 new ordinary shares of the Company were vested in December 2020; and (c) share options to subscribe for 6,056,200 new ordinary shares of the Company were vested in June 2021.
